The Standard CEIF and the Model of Excellence CEIF provide the necessary structure to the Intitutions for the Infancy and Families pursuing its educational and social purposes and making feasible what determined by the INTERNATIONAL BILL OF RIGHTS OF THE CHILD, ratified by 193 nations:



"The child is an autonomous entity with inalienable educational rights to life, education, learning and respect of individual, ethnic, linguistic, cultural and religious identity, which underpins the promotion of a new quality of life and a new acquisition of socio-cultural identity as a citizen active and participant in the socio-cultural changes."



Description of the Standard

To obtain the Certification of the Standard CEIF and/or its Model of Excellence, the Educational Institution must produce the following series of documents that describe the practices, procedures and strategies of the system, processes and delivery:

- ❖Work Plan of the economic objectives and of the organizational structure that the Management Body intends to pursue;
- ❖ Educational Planning of educational goals and learning paths that the Educational Direction intends to pursue;
- ❖ Teaching Programming of activities with children and families, carried out by each teacher;
- Quality Manual and management and assessment Procedures.






Structure of the Standard:

The Standard CEIF and its Model of Excellence are articulated in following points:


- ✓ Specific accreditation of Educational Institutions for the Infancy and Families
- ✓ Scope, Regulations and Fields of Application of Services for the Infancy and Families
- ✓ Quality of Management of the Organization and Management
- ✓ Quality of Management in the Human and Professional Resources
- ✓ Quality of Education of the Educational and Teaching System
- ✓ Social Quality of relationships with Families and Social Environment
- ✓ Quality of Certification of the Educational System and Services.



Fields of Application for the Services for the Infancy

The Standard CEIF applies to the following Services for the Infancy:

- Educational Services for early childhood 0-3 years, however called;
- Educational Services for childhood 3-6 years however called;
- Centers for the infancy for children from 1 to 6 years;
- Integrated Services for the Infancy and Families, for children of 0-3 years or 3-6 years or 0-6 years;
- Regional Educational Services (to be taken into account only if used together with another service of this standard);
- Innovative Services (to be taken into account only if used together with another service of this standard).







Fields of Application for the Services for the Families

The Standard CEIF This standard applies to the following Services for the Families:

- Services of Reception Desk for Families , however called;
- ➤ Services of the Family Center, however called;
- ➤ Advisory Services to Families, however called;
- ➤ Services of Game Centers Recreational Centers for children and families;
- ➤ Social and family mapping services in the area (only with other services of the standard);
- ➤Innovative Services (only with other services of the standard).







Benefits of the Certification:

The Institutions for the Infancy and Families, through the Certification of the Standard CEIF and even more of its Model of Excellence – could be recognized internationally, nationally and / or regionally as Educational Institution of public utility.

The Certification has a three years validity, subjected to annual surveillance audits.

Obtaining the Certification means to:


- obtain a proof and recognition of quality of its Training Services;

The Advanced Traning Course on the Standard:

The Advanced Training Courses on the Standard CEIF and on the Model of Excellence are delivered by the E.C.E. - European Center of Education



The Courses are developed in 300 hours (which can be recognized as 12 CFU - University credits).

The Courses are organized by AJA Academy.







The Training Structure:

The courses are structured as follows:

- ✓ 60 hours of class training featured by theoretical scientific and technical -methodological lectures and/o r workshops on the following topics:
 - •the Certification of the Standard;
 - the Educational Policy of the system and of training services for the Infancy and Families;
 - the Quality of the system and of training services for the Infancy and Families;
 - the Educational evaluation of the services for the Infancy and Families;
 - the Methodology and Tools for the Certification of the Standard CEIF.







The Training Structure:

- √80 hours of Training in E-learning on issues concerning the content of the Standards and legislation;
- √80 hours of training Stage on site, during which the students carried out assessment activities in coaching;
- √80 hours of documentation and E-learning communication characterized by the analysis and evaluation of case studies and monitoring on-line, described in the final report of the training process;
- ✓ Assessment by the Technical-Scientific Committee made up of 5 Experts, based on:
 - the final report of the training cycle;
 - the final exam on the knowledge and analysis of cases of the Standard CEIF.
